2026-27 SCHOOL YEAR

SPECIAL EDUCATION SERVICES AGREEMENT

THIS AGREEMENT is made this **June 16, 2026** between the **BUCKS COUNTY INTERMEDIATE UNIT #22** located at **705 N. Shady Retreat Road, Doylestown, PA 18901** ("BUCKS IU") and the **HATBORO-HORSHAM SCHOOL DISTRICT** located at **229 Meetinghouse Road, Horsham, PA 19044** ("SCHOOL ENTITY"). The parties agree as follows:

1. The BUCKS IU shall provide during the 2026-2027 school year the services outlined in the **attached Schedule of Projected Costs** and shall do so in accordance with the requirements of state and federal law.
2. The SCHOOL ENTITY shall remain responsible for the provision of any program, service, evaluation, equipment, or device that is not included in the attached Schedule of Projected Costs. Nothing in this agreement shall be deemed or construed to establish the Bucks IU as the responsible local educational agency for purposes of implementing any requirement of state or federal law or to render the Bucks IU liable to any third party, including the parents or guardians of children receiving services in accordance herewith. The relationship of the Bucks IU and the SCHOOL ENTITY under this agreement shall be that of independent contractor to principal, and nothing herein shall be deemed or construed to render any employee of either entity an employee of the other for any purpose whatsoever.
3. The SCHOOL ENTITY shall pay to the BUCKS IU the total cost specified in the attached Schedule of Projected Costs, subject to the adjustments agreed to by both parties, as follows:
 - Where the total Schedule of Projected Costs is less than \$750,000, payment is due on or before August 15, 2026.

- Where the total Schedule of Projected Costs is greater than or equal to \$750,000, payment is due in five installments: 20% on or before August 15, 2026; 20% on or before October 15, 2026; 20% on or before December 15, 2026; 20% on or before February 15, 2027; 20% on or before May 15, 2027.

Reconciliation shall occur on or before October 15, 2027, and payment of any amounts due based on reconciliation shall occur on or before December 15, 2027. For purposes of this agreement, “reconciliation” shall consist of a comparison of the actual costs incurred by the BUCKS IU in the performance of this agreement during the school year with the total payments made by the SCHOOL ENTITY and, if actual costs exceed total payments, payment of the difference by the SCHOOL ENTITY to the BUCKS IU or, if total payments exceed costs, credit of the difference by the BUCKS IU to the SCHOOL ENTITY. Any adjustments to the number of students in the BUCKS IU programs that occur during the school year will be reflected in the reconciliation.

4. The obligations of the parties under the agreement are contingent upon the existence of similar agreements with other school districts in sufficient number to enable the Bucks IU to provide the services specified. The Bucks IU may elect to terminate this agreement upon ten (10) days written notice if the total students enrolled in the program or class declines by fifty percent or more or if any action or inaction of the state or federal government necessitates, in the judgment of the Bucks IU Board on recommendation of the Executive Director, discontinuation of the program or class in whole or in part provided, however, that the termination shall be effective only to the extent required by such action or inaction. The obligations of the Bucks IU under this agreement are further contingent upon the availability of appropriate classroom space sufficient to enable the Bucks IU to provide the services specified in the attached Schedule of Projected Costs.
