

C O N T R A C T
BETWEEN
THE BOARD OF SCHOOL DIRECTORS
AND
ROTHMAN ORTHOPAEDICS

THIS AGREEMENT made and entered into this 29th day of April, 2026 by and between Reconstruction Orthopaedics Associates (D/B/A Rothman Orthopaedics), 833 Chestnut Street, Philadelphia, PA 19107 (hereinafter referred to as "Rothman" and the BOARD OF DIRECTORS OF THE CENTRAL BUCKS SCHOOL DISTRICT, that Dr. Edward Rosero, DO, shall serve under the authority of the said Board as an independent contractor in the capacity of Physician and Medical Examiner to the Central Bucks School District for the 2026 - 2027 school year, to be available for a minimum of 190 days at an annual compensation of Seven Thousand Eight Hundred Dollars (\$7,800.00) payable in January, 2027 and June, 2027 in two (2) equal installments, less proper deductions for loss of time.

Except, however, that the full compensation will not be paid in the event of a school closure in excess of ten (10) days due to a force majeure event. Under those circumstances, compensation shall be prorated based upon the percentage fulfillment of services as outlined in this contract. For the purpose of calculating compensation, it is only paid in the event the service is rendered and is not fixed, notwithstanding the amount of services provided.

Sixty days' notice shall be required before termination of this contract by either party. The following services shall be performed under the terms of this contract:

1. To be present at home football games as required for the Central Bucks High School West. If unable to be in attendance, a responsible substitute physician will be procured by the physician named in this contract as his agent and paid by the named physician.
2. To be present at home wrestling matches for the Central Bucks High School West. If unable to be in attendance, a responsible substitute physician will be procured by the physician named in this contract as his agent and paid by the named physician.

Independent contractors to schools are required to comply with the requirements for background certifications as set forth in the Public School Code and the recent revisions to the Child Protective Services Law (adopted July 1, 2015). Additionally, the Pennsylvania Public School Code Section 1418 requires Medical Examinations of anyone providing direct care to children. The law does not allow modification of this section. All subcontracted physicians must adhere to these requirements.

Rothman Orthopaedics shall provide proof of appropriate liability insurance coverage for Rothman employee's providing services at wrestling matches and football games. In addition, Rothman agrees to indemnify and otherwise hold the District harmless for any acts of Rothman employees providing services under the terms of the herein agreement.
