Personal Electronic Devices

Purpose

The Board adopts this policy to support an educational environment that is orderly, safe, secure, and conducive to learning while recognizing that personal electronic devices may provide educational benefits when used appropriately.

The Board further recognizes that the misuse of personal electronic devices may disrupt instruction, compromise student and staff safety, interfere with the educational process, invade the privacy of others, and negatively impact student well being.

The Board also recognizes that reasonable limitations on personal electronic devices promote student engagement, academic integrity, digital citizenship, student well being, and a safe, orderly, and focused educational environment while allowing the District flexibility to respond to changes in technology, educational practices, school safety, and applicable law.

Definition

For purposes of this policy, personal electronic devices include, but are not limited to:

- Cellular phones and smartphones;
- Smartwatches;
- Earbuds and headphones;
- Tablets and e readers;
- Smart glasses, including prescription smart glasses, augmented reality devices, and AI enabled eyewear;
- AI enabled wearable devices;
- Cameras and recording devices;
- Portable gaming devices; and
- Any privately owned electronic device capable of photographing, audio recording, video recording, livestreaming, communicating, messaging, storing, transmitting, receiving, displaying, or accessing data, media, internet services, artificial intelligence applications, or other digital content.

This policy governs student owned personal electronic devices. District issued technology shall be governed by other applicable Board policies and administrative regulations.

Authority

Student possession and use of personal electronic devices during the school day shall be governed by this policy and administrative regulations adopted by the Superintendent or designee.

The Board recognizes that the possession, storage, access to, and use of personal electronic devices during the school day may be reasonably restricted when necessary to promote student learning, maintain a safe and orderly educational environment, protect student and staff safety, or comply with applicable federal or state law, Pennsylvania Department of Education guidance, or district operational needs.

The Board authorizes the Superintendent or designee to establish and implement administrative regulations governing the possession, storage, access to, and use of personal electronic devices, including the implementation of reasonable restrictions during the school day when necessary to carry out this policy or comply with changes in law, Pennsylvania Department of Education guidance, or district operational needs.

In the classroom, the use of personal electronic devices for educational purposes shall be at the discretion of the classroom teacher except as otherwise provided by Board policy or administrative regulation.

The Board prohibits the use of personal electronic devices in locker rooms, restrooms, health suites, changing areas, or any location where an individual has a reasonable expectation of privacy.

Exceptions

The building principal or designee may approve possession or use of a personal electronic device for:

1. Health, safety, or emergency reasons.
2. An Individualized Education Program (IEP), Section 504 Service Agreement, Individualized Health Plan, or other approved accommodation.
3. Classroom or instructional activities under the supervision of a teacher.
4. School related activities approved by a teacher, coach, advisor, or administrator.
5. Other circumstances determined appropriate by the building principal or designee.

Authorized Use of Personal Electronic Devices

The Board authorizes students to use personal electronic devices only for educational purposes when approved and supervised by a teacher or other authorized district employee, or as otherwise permitted by this policy or administrative regulation.

When educational, medical, accessibility, safety, or emergency use of a personal electronic device is approved by the building principal or designee, or required by a student's Individualized Education Program (IEP), Section 504 Service Agreement, Individualized Health Plan, or other approved accommodation, such use shall be supervised as appropriate.

The District assumes no responsibility for the loss, theft, damage, or misuse of any personal electronic device brought onto school property or to a school sponsored activity.

Recording, Photography, and Privacy

Students shall not use any personal electronic device to photograph, audio record, video record, livestream, or otherwise capture, create, possess, transmit, post, or distribute images, audio, or video of any student, employee, volunteer, visitor, classroom activity, school operation, or incident occurring on school property, while participating in district transportation, or at school sponsored activities unless expressly authorized by a teacher or administrator for an approved educational, instructional, medical, accessibility, safety, or school related purpose or otherwise permitted by law.

Students shall not use the electronic functionality of smart glasses, including prescription smart glasses, AI enabled eyewear, or any wearable electronic device capable of recording audio, video, photographs, communicating, transmitting data, or accessing artificial intelligence applications unless expressly authorized by a teacher or administrator for an approved educational, instructional, medical, accessibility, safety, or school related purpose.

Students who witness a fight, altercation, medical emergency, safety concern, threat, or other incident requiring staff intervention are expected to immediately notify a school employee or other responsible adult. Recording, photographing, audio recording, livestreaming, posting, transmitting, distributing, or delaying the reporting of an incident in order to record or share it may constitute a violation of this policy and the Student Code of Conduct.

The Board prohibits the taking, storing, transmitting, viewing, disseminating, or sharing of obscene, pornographic, lewd, illegal, or otherwise prohibited images, videos, recordings, or other electronic media.

Conduct that may constitute a violation of federal or state law may be referred to the appropriate law enforcement agency.

Delegation of Responsibility

The Superintendent or designee shall annually notify students, parents or guardians, and employees regarding this policy.

The Superintendent or designee shall develop, implement, and periodically revise administrative regulations necessary to carry out this policy.

Administrative regulations may establish procedures governing:

- Possession of personal electronic devices;
- Storage requirements;
- Access to personal electronic devices;
- Approved and prohibited uses;
- Classroom expectations;
- Restrictions during the school day, including bell to bell expectations when required by law or determined appropriate by the District;
- Wearable technology;
- Approved exceptions;
- Enforcement procedures;
- Disciplinary procedures; and

- Other operational requirements necessary to implement this policy.

Administrative regulations may be revised without amendment to this policy, provided they remain consistent with Board policy and applicable law.

Guidelines

Students are responsible for the security of any personal electronic device brought onto school property or to a school sponsored activity.

Unauthorized photographing, audio recording, video recording, livestreaming, or the creation, possession, transmission, posting, or distribution of images, audio, or video of students, employees, volunteers, visitors, classroom activities, school operations, or school related incidents through any personal electronic device shall constitute a violation of this policy and the Student Code of Conduct and may result in disciplinary action.

Violations of this policy or applicable administrative regulations may result in disciplinary action consistent with the Student Code of Conduct and may include confiscation of the personal electronic device.

The return of confiscated personal electronic devices shall be governed by administrative regulation.

237.1-AR-0. IMPLEMENTATION PROCEDURES FOR PERSONAL ELECTRONIC DEVICES

Personal Electronic Devices

This Administrative Regulation establishes procedures for implementing and enforcing Board Policy 237 regarding student personal electronic devices.

Building Level Responsibilities

Principals or designees shall:

- Establish and communicate building specific procedures for the storage and use of personal electronic devices.
- Ensure that classroom storage pouches or organizers are available and utilized in Grades 9 through 12.
- Provide annual training to staff regarding expectations and enforcement procedures.
- Monitor compliance and ensure consistent application of the policy.
- Communicate procedures and expectations to students and families annually.
- Establish procedures for documenting violations and securing confiscated devices.
-

Staff Responsibilities

Teachers and staff shall:

- Reinforce the District's expectations regarding personal electronic devices.
- Require students in Grades 9 through 12 to place cell phones in designated classroom storage pouches or organizers upon entering each classroom.
- Ensure students in Grades 6 through 8 keep personal electronic devices away and out of sight throughout the school day.
- Ensure students in Grades Kindergarten through 5 do not possess or use personal electronic devices during the school day unless an approved exception applies.
- Not permit access to personal electronic devices except as authorized under Board Policy 237.
- Document violations in accordance with building procedures.
- Turn confiscated devices over to the main office or designated administrator when necessary.

Student Procedures

Grades Kindergarten through 6

- Students shall not possess or use personal electronic devices during the school day unless expressly authorized by the building principal or designee for a documented educational, medical, safety, or other approved purpose.
- Any approved personal electronic device shall remain powered off or silenced and shall only be accessed for the approved purpose.

Grades 7 through 8

- Students shall keep personal electronic devices powered off or silenced and secured in a backpack or other approved location throughout the school day.
- Personal electronic devices shall remain away and out of sight at all times.
- Students shall not access or use personal electronic devices during the school day unless authorized under an approved exception.

Grades 9 through 12

- Students shall place their cell phone in the designated classroom storage pouch or organizer immediately upon entering each classroom.
- Students shall retrieve their device at the conclusion of the class period and place it in the designated storage pouch upon entering their next classroom.
- Outside of class periods, including passing time, lunch, study halls, assemblies, and other school activities during the instructional day, personal electronic devices shall remain away and out of sight unless specifically authorized by a staff member.
- Students shall not access or use personal electronic devices during the school day unless authorized under an approved exception.

Wearable Technology

Students shall not use smartwatches, smart glasses, earbuds, headphones, or any other wearable technology in a manner that permits communication, recording, internet access, messaging, streaming, or other digital interaction during the school day.

Students shall not use one personal electronic device in place of another to circumvent Board Policy 237.

Approved Exceptions

The Superintendent or designee may authorize exceptions for:

- Documented medical needs.
- Accommodations required by an Individualized Education Program (IEP) or Section 504 Plan.

- Limited educational purposes approved by both the classroom teacher and the building principal or designee.
- Emergency situations as determined by school administration or safety personnel.

Approved instructional use shall be limited to the duration necessary to accomplish the educational objective.

Enforcement Guidelines

Violations of Board Policy 237 shall be addressed through progressive discipline and in accordance with the Student Code of Conduct and Administrative Regulation 237.1.

Administrators may:

- Confiscate personal electronic devices.
- Require parent or guardian notification or conferences.
- Assign detention or other disciplinary consequences.
- Require parent or guardian retrieval of devices for repeated violations.
- Implement behavioral contracts or additional interventions for repeated or willful noncompliance.

Communication

The District shall provide annual communication regarding Board Policy 237 and this Administrative Regulation through student handbooks, orientation programs, district communications, and other appropriate means.

Building principals shall ensure students and families are informed of expectations at the beginning of each school year.

Review

This Administrative Regulation shall be reviewed annually by the Superintendent or designee and revised as necessary.

PURPOSE

The district shall utilize integrated pest management procedures to manage structural and landscape pests and the toxic chemicals used for their control in order to alleviate pest problems with the least possible hazard to people, property and the environment.

DEFINITIONS

Integrated Pest Management (IPM) is the managed use of combined pest control alternatives, including cultural, mechanical, biological and chemical to most effectively prevent or reduce to acceptable levels damage caused by pests.[\[1\]](#)

Integrated Pest Management Plan is a plan that establishes a sustainable approach to managing pests by combining biological, cultural, physical and chemical tools in a way that minimizes economic, health and environmental risks.[\[2\]](#)

AUTHORITY

The Board establishes that the district shall use pesticides only after consideration of the full range of alternatives, based on analysis of environmental effects, safety, effectiveness and costs.[\[3\]\[4\]](#)

The Board shall adopt an IPM Plan for district buildings and grounds that complies with policies and regulations promulgated by the Department of Agriculture.[\[2\]\[4\]](#)

The Board shall designate an employee to facilitate IPM for the district. The designated employee will be referred to as the district's IPM Coordinator or as otherwise specified at the district.

DELEGATION OF RESPONSIBILITY

The IPM Coordinator shall be responsible to implement the IPM Plan and to coordinate communications between the district and the approved contractor.

The IPM Coordinator shall be responsible to annually notify parents/guardians of the procedures for requesting notification of planned and emergency applications of pesticides in school buildings and on school grounds.[\[5\]](#)

The IPM Coordinator shall maintain detailed records of all chemical pest control treatments for at least three (3) years. Information regarding pest management activities shall be available to the public at the district's administrative office.[\[5\]](#)

Appropriate personnel involved in making decisions relative to pest management shall participate in periodic training, as needed.

GUIDELINES

Pest management strategies may include education, exclusion, sanitation, maintenance, biological and mechanical controls, and site appropriate pesticides.

An IPM Plan shall include the education of staff, students and the public about IPM policies and procedures.

When pesticide applications are scheduled for district buildings and grounds, the district shall provide notification at least seventy-two (72) hours in advance in accordance with law, including:
[\[5\]](#)

1. Posting a pest control sign in an appropriate area, at the place to be treated. The sign shall remain in place for at least two (2) days following each planned treatment.
2. Providing the pest control information sheet to all individuals working in the affected school building.
3. Providing required notice to all parents/guardians of students or to a list of parents/guardians who have requested notification of individual applications of pesticides.

Where pests pose an immediate threat to the health and safety of students or employees, the district may authorize an emergency pesticide application and shall notify by telephone any parent/guardian who has requested such notification.[\[5\]](#)
