Attached is the Costars proposal from the Tustin group to repair the middle School A/C unit.
My recommendation is we accept this proposal.

This unit is 20 years old and appears to have the original compressors and since this is a heat pump system and the compressors run in heating and cooling, I feel we got the life out of the system.

According to ASHRAE guidelines, air-to-air heat pumps have a median lifespan of **15 years**. However, this varies depending on type: commercial water-to-air (geothermal) heat pumps can last **over 20 years**.
